Oak Foundation: Far From Neutral: The Swiss-Based Group Steering U.S. Environmental Policy



Established in 1983 by British billionaire Alan M. Parker after making a fortune in the international retail industry, the nebulous, **Swiss-based Oak Foundation (OF)** has quietly become a “key player within climate philanthropy” and advocacy. OF maintains a presence in multiple countries across the globe, including the United States, all while several of founder Alan Parker’s family members sit on the group’s Board of Trustees. With the organization’s leadership admitting that their advocacy work means “engaging with various political entities,” OF backs a host of radical climate positions,

including supporting opposition to the Keystone XL pipeline, extreme and impractical carbon “net-zero” targets, and backing movements that push for implementing the goals of the Paris Climate Accords.²⁴

OF also maintains that **“climate justice” is at the center of its work**, and that it engages at the “intersection of race, equity, gender rights, and social justice.” One of its approaches to realizing its agenda involves “using finance as a lever for change” to “challenge” the fossil fuel sector, and the organization listed in a 2023 report that it supports “efforts that use innovative and disruptive finance strategies to end public money for coal, oil, and gas expansion or production.”²⁵

One of the most alarming “disruptive financial strategies” being used by OF to force their extreme green agenda is the backing of a slew of radical U.S.-based groups helping towns, counties, and states all across the country file climate lawsuits against energy companies for alleged damages as a result of climate change. OF has given millions to groups that have openly and aggressively supported and publicized climate litigation in the media, online, and most importantly, the courts. Well-funded anti-fossil fuel groups are turning to the legal system to enact their agenda.

A September 2024 report found that at least 26 liability lawsuits have been filed by “cities, counties and states against fossil fuel producers... seeking compensation and accusing companies of misleading consumers about their role in warming the planet.”²⁶

Power from the
ground up

The Center for Community Change, now known as Community Change, “supports racial justice advocacy and progressive

organizing campaigns,” and has received **\$1.6 million** in foreign money from Oak Foundation.

Community Change sprang into the spotlight in August 2025 after it was revealed that they were the “fiscal sponsor” for **Free DC**, a group that mobilized to protest President Trump’s crackdown of crime in Washington, D.C. Free DC is behind multiple radical resistance and protest events, including a “Cop Watch Training,” and their “guiding principles” include “Do not obey in advance” and “Take up space.”²⁸

ROCKEFELLER Philanthropy Advisors

Rockefeller Philanthropy Advisors (RPA), another top recipient of Oak Foundation cash, has raked in over **\$108 million** since 2016. Founded in 2002, RPA serves as a dark money ATM for passing foreign money into a host of left-wing advocacy organizations. In 2023, their last available tax return on file, RPA granted over \$400 million to progressive groups, including the Arabella Advisors and Tides networks.²⁹
